We all know patient no shows are a big problem. These missed appointments result in scheduling gaps, lost revenue and staffing issues.

So how do you solve the problem? Do you write down the appointment, hand your patient an appointment card, cross your fingers and hope your patient doesn't misplace their appointment reminder? Or do you pull your staff from important patient care and ask them to make reminder calls? Or maybe you rely on overbooking—estimate your average number of no shows, then overbook your schedule, while praying that not everyone shows up!

Each method does not work very well!

Your NO-SHOW rate may not be as high as the national average. For most offices, NO-SHOWS range from 5 to 18%. Even so, this can add up to a staggering amount of lost revenue.

Let's look at an example. Dr. Harris sees 80 patients per day at his busy ophthalmology practice. His no-show rate is 10%. That means that on most days he's likely to have at least 8 no-shows. If Dr. Harris decreases his NO-SHOW rate to 5%: Based on 22 workdays a month and a cash rate of \$100.00 per visit, he will increase his revenue by \$400 per day or \$8,800 per month or \$105,600 per year.

Mobile technology offers a solution
